**AFFIRMATION OF DRIVER LICENSE
AND VECHICLE INSURANCE**

THIS FORM MUST BE COMPLETED ANNUALLY OR AS CHANGES IN A DRIVER'S PROFILE OCCUR

Nevada Revised Statutes and Nevada Grand Assembly requires all drivers of any vehicles ("Driver(s)") to, from or at a Nevada Grand Assembly sponsored function ("Function"), which transports participants or other volunteers, to have a valid driver's license. The same also requires the owner of any vehicle registered to drive on public streets ("Vehicle Owner(s)") and for the purpose stated above to carry the proper liability insurance to cover damages of bodily injury to another party and property damage to other's property.

Nevada Grand Assembly requires proof of a valid driver's license and proof of insurance for any and all Driver(s) and proof of valid vehicle insurance coverage by all Vehicle Owner(s) showing at least the minimum threshold of automobile insurance for Bodily Injury/Property Damage coverage as required by Nevada Revised Statute 485.185, for all Driver(s) and Vehicle Owner(s). Specifically, Drivers are required to have protection levels of at least \$15,000 per person for bodily injury, \$30,000 per accident for bodily injury, and \$10,000 per accident for property damage, often referred to as 15/30/10. This requirement is for the protection of all Nevada Grand Assembly participants and volunteers. Unless these forms are on file with the Supreme Officer or her designee (collectively "Supreme Officer"), a participant or volunteer is not permitted to ride in the vehicle or with the driver. These forms are to be kept current and it is the responsibility of the driver and/or owner to update the information on file with Nevada Grand Assembly accordingly. Additionally, proof of a valid driver license and valid insurance coverage must remain with the driver and vehicle at all times during the Function for which transportation is being provided.

Additionally, the undersigned Driver(s) and/or Vehicle Owner(s) agree to be fully and solely responsible for payment or reimbursement of any damages, medical charges or expenses incurred on behalf of any participant or volunteer for which the Driver(s) or Vehicle Owner(s) are found at fault, during the Function. This reimbursement is including but not limited to any coverage that vehicle insurance may provide to the participant and/or volunteer. Driver(s) and Vehicle Owner(s) agree that participants and volunteers may seek reimbursement for any damages from all applicable insurance policies, regardless of Driver(s) or Vehicle Owner(s) fault. The undersigned Driver(s) and/or Vehicle Owner(s) further agree to indemnify and hold harmless Nevada Grand Assembly, the Supreme Officer, all members and volunteers of Nevada Grand Assembly, the International Order of the Rainbow for Girls, all Assemblies of Nevada Grand Assembly, the Masonic Fraternity, and any sponsoring body or affiliates thereof from any claim, demand or action which may be initiated, by any 3rd party, individual, organization or entity, against aforementioned parties for the recovery of such medical expenses, including any legal fees or expenses incurred in defending against such claims.
